Such investments include Singapore fixed income deposits, short-term government and corporate bonds, commercial bills and deposits with financial institutions and similar assets.

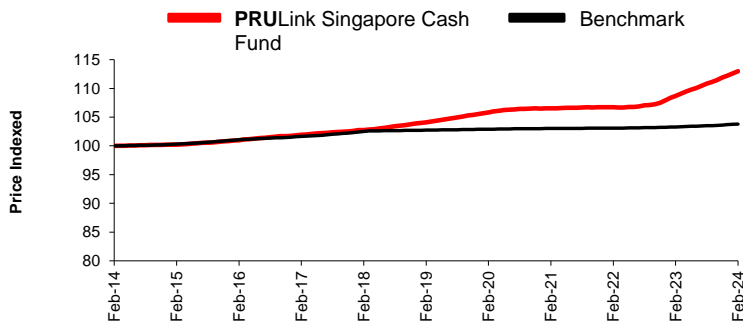
