**Investment Objective**

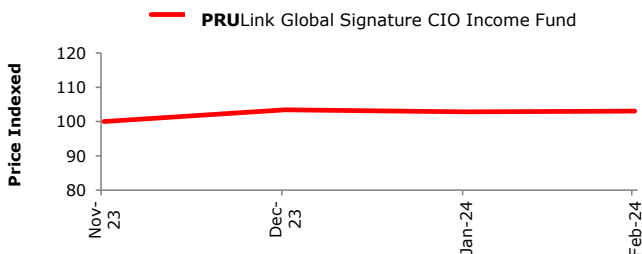

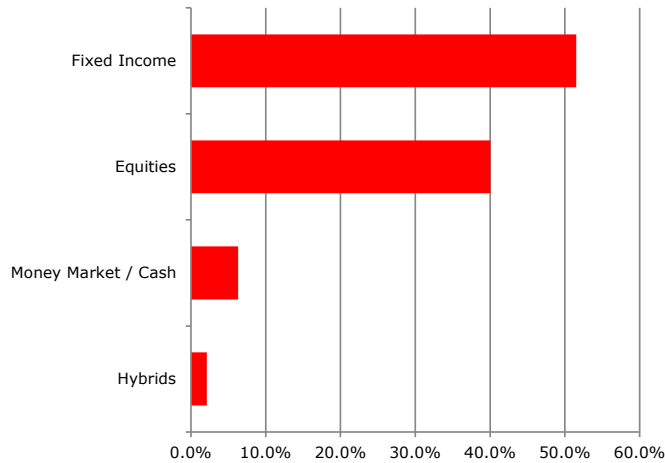
