

SUPPLEMENTAL DEED – SECTION 73 CLPA TRUST AND EDUCATIONAL/JUVENILE TRUST

Change of Trustees of trust effected under
Section 73 of the Conveyancing and Law of Property Act
or Educational Trust or Juvenile Trust

 - If no trustee is living when the policy money becomes payable, settlement cannot be made until it has been established from whom Prudential may correctly accept a discharge. It is therefore advisable when considering
- your choice of trustees to arrange, as best as possible, at least one trustee who is likely to outlive the life assured. No amendments or corrections (e.g countersigning, correction tape, correction fluid) can be made on the form
